Dave Neyer, President of Georgia Student Scholarship Organization, will present detailed information about Student Scholarship Funding and answer any questions you may have about GA House Bill 1133:

The state of Georgia has passed legislation (GA House Bill 1133) that allows any Georgia taxpayer, including C-Corps and S-Corps to redirect a portion of their state income tax to the private school of their choice. The business receives a 100% dollar for dollar tax credit (not a deduction) for their donation. The state of Georgia has allocated \$100 million dollars for this program annually. This allows the business owner the ability to redirect tax money how they see fit and keep their tax dollars in their local communities. Additionally, in August of 2020, the IRS updated their regulations (IRS Document 2020-17939) for deductibility of GaSSO payments on their federal tax returns. This is significant because this would qualify your business for federal tax savings in addition to the state income credit you would receive!

In addition, you can tour Challenge Preparatory Academy Day School that is in the Harrisburg community, and **enjoy lunch on us!** We encourage each of you to come and hear how you can save money and help our school at no cost.
